2024 Annual Book of Reports: President's Report

The 2023-2024 Board of Directors had monthly virtual meetings from December 2023 to July 2024 with a combined August/September 2024 virtual meeting and one face-to-face meeting in Albany at the ANA-NY office on May 8, 2024.

President Updates:

- Facilitated monthly meetings of the ANA-NY Organizational Affiliates to discuss common issues, advocacy, and legislative priorities
- Presented an analysis of the NCSBN Nurse Licensure Compact (NLC) at the 2023 Annual Meeting to educate members about supporting advocacy over the next year
- Recorded learning on demand presentations on ANA-NY YouTube on the Nurse Licensure Compact and Nurses: Caregivers, not Criminals (case study on criminalization of malpractice)

- The Annual Meeting was held at Turning Stone Resort in Verona, New York. November 9-11,

- The Board approved a proposal for Political Action Committee (PAC) appointments.
- The Board approved renewal of the contract for CINAHL services for ANA-NY members and staff to support research and literature reviews for whitepapers and other papers
- ANA-NY signed a contract with a new publisher for the ANA-NY newsletters and Journal of the ANA-NY HCM HealthCom Media
- The Board welcomed new Organizational Affiliate: Oncology Nursing Society New York City Chapter
- The Task Force on Health Equity convened to advance work toward health equity in New York
 State
 - Task Force Members: Marilyn L. Dollinger, Giselle Gerardi, Cynthia LaRocca, Teddi Levine, Seon Lewis-Holman, Kerlene Richards, and Kim Velez
 - o The Task Force was awarded a grant from ANA for \$8000 to support this work
- Participated in a coalition with the New York State Emergency Nurses Association (NYSENA) and American College of Emergency Physicians of New York State (ACEP of NYS)
 - o Presented at the April 2024 NYSENA conference on workplace violence
 - Present at the NYS legislature to receive the resolution proclaiming April as workplace violence prevention month in New York State
- The Board approved the concept of a hospital governance bill presented by ANA-NY lobbyist Amy Kellogg. This is the first piece of legislation introduced by ANA-NY.
 - The bill will require a registered nurse on all hospital system governance boards in New York State
- Successful ANA-NY Lobby Day May 7, 2024 in Albany, New York
- Sponsored one ANA-NY member for the American Nurses Advocacy Institute in Washington D.C.
- The board approved sponsorships (\$5958) and donations (\$500) to organizations.
- Board received "clean" audit of ANA-NY finances.
