Education Committee

Report details/accomplishments

•The committee has followed various issues, including the implementation of BS in 10, the advancement of simulation as an educational strategy, diversity in nursing education & holistic admissions, and the recent release of the National Academy of Medicine Future of Nursing report.

•Suzanne Sullivan, the Executive Secretary of the State Board for Nursing, attended the April meeting to engage in dialogue about members' opinions as to what constitutes effective clinical education and barriers to the same.

•In May, Dr. Pam McCue, the Chief Executive Officer of the Rhode Island Nurses Institute Middle College, gave a presentation on this innovative model of a college preparatory high school, designed to get high school graduates from diverse backgrounds prepared for the rigors of nursing education programs. Plans for replicating the model in the Capital Region are underway. ANA-NY has submitted a letter of support for the charter school application.

•At the August meeting, Dr. David Armstrong from the Center for Health Workforce Studies at the University at Albany gave a presentation on the annual survey of NYS nursing education programs' deans and directors. He presented data comparing factors from pre-Covid and during Covid, such as demand for seats in nursing programs (applications), faculty availability, and ease of clinical placement.

•The committee said goodbye to our previous student representative, Jordyn Preslar, and welcomed a new student representative, Brianna Augustin. Both are active members of NSANYS.

•The committee ensured the submission of three continuing education articles for the ANA-NY newsletter.

•Several committee members participated in the review of posters that were submitted for the annual convention.
