The main bill the committee focused on this year was safe staffing. ANA-NY strongly supported the bill, and it reflects a model that ANA-NY had strongly advocated for years. A108-B sponsored by Assembly member Gunther, and S1168-A sponsored by Senator Rivera, relied on outcomes-based staffing, which is based on research and evidence-based practices, and would require each hospital to establish an ongoing commitment to create and have the authority to implement nurse staffing plans that are specific to each unit of the hospital or long-term care setting. This legislation would also require the public reporting of these staffing plans and tracking the care outcomes.

The Safe Staffing Bill (A108-B/S1168) was signed by the Governor on 6/18. This bill relates to staffing in acute care hospital settings. A separate bill focused on Nursing Home Staffing Levels (A7119/S6346P) was created to address nursing home facilities. This bill included set staffing ratios and was signed into law on 6/18.

A Racial equity bill (A5679-A /S2987) to address racism as a public health crisis was created, and ANA NY provided a memo of support.

Community paramedicine bill to provide expanded privileges for paramedics in the community (A151/S1590). ANA-NY has historically opposed the bill because of concerns related to lack of definition of the scope of practice of community paramedicine, nature of supervision, and the possibility of impeding nursing practice; however, concern for community access to care is shared. Amy Kellogg reached out to bill sponsors regarding areas of concern and potential amendments to the bill.

The Legislation committee reviewed legislation to require continuing education for nurses in New York. These educational, legislative activities included Bills addressing Continuing education hours for nurses and simulation hours permissible for prelicensure RN clinical degree programs.

ANA NY has met with NYSNA to discuss ways to best collaborate and partner together regarding legislative activities. ANA-NY continued coalition efforts to raise awareness on the value of immunizations and continued work with the Tobacco-Free New York Coalition.



Virtual lobby week ran from Wednesday, May 6th, and for the duration of National Nurses Week, which ran through May 12th. This year's theme for National Nurses Week is "Nurse: A Voice to Lead." Given all that has occurred over the past year during the COVID-19 pandemic, this theme is appropriate. There were 59 participants for virtual lobby week and 128 connections.

The work of the NY legislature for the remainder of the session related to bills of local interests such as sales tax and pension bills.
