Organizational Affiliates – Had our second OA Legislative Priorities meeting on Tuesday, April 11th at 6 pm. The next meeting is scheduled for May 16th at 6 pm and they will continue to meet the 3rd Tuesday of each month. I have added the notes from the last 2 meetings on the Board of Directors SharePoint site as well. We also had 8 OA's (NYSANA, Chi Gamma, NACLI, NYLN, NYSASN, PNASC, PNASCNY, & PNADP) request co-branded ads for Nurses Week, which is the most we've had to date. Those have all been created and sent to their respective newspapers for inclusion.

Leg Committee - Next meeting was rescheduled for May 11th so as not to coincide with the information session for Advocacy Day, which took place on May 4th at 7 pm.

Abstract Review Subgroup - Attended and took minutes at April 20, 2023, meeting.

Newsletter - Completed editing for April 2023 newsletter. I reached out to all columnists to remind them of July's newsletter column submission deadline, which is June 1, 2023. I also reached out to the Program Committee to let them know that we will be spotlighting them in the July newsletter and asked for a brief bio and picture to include. I am currently working on the table of contents and collecting articles.

FNL Award – We had 17 FNL Awardees this year! I updated and mailed all the presenting faculty members the Awards packet, which included the FNL Award Certificate and congratulatory letter that is to be presented to the student, as well as a dual ANA-NY and ANA membership application that is good for a one-year complimentary membership, once they receive licensure, and talking points that the presenter can include in their speech. I have also connected with Brittany regarding the press releases for the Awardees and will include their information in the July newsletter as well.

Special Interest Groups – Based on the BOD's approval we added 2 new SIG topics, Addressing the Nursing Shortage and Technological Advances in Nursing Practice. Brittany updated the marketing materials to reflect the new topics and we have already had a few members sign up for them. The Climate & Health group held its first meeting on Thursday, April 13th and has its next meeting scheduled for May 9th at 6 pm. The Policy & Advocacy group will hold their first meeting on May 15th at 2 pm and the other 3 groups have yet to determine a date and time for their initial meeting.
